

# Minutes of Regular Scheduled Board Meeting Dawson County Hospital District August 30, 2022

1. Call to Order: David Sanderson, Board President, called the meeting to order at 5:01 p.m., with the above-mentioned members, staff and guest present.

- 2. Invocation: The invocation was given by David Sanderson, Board President.
- **3. Pledge of Allegiance:** The pledge of allegiance was given by David Sanderson, Board President.
- 4. Public Hearing on 2022 Preliminary Tax Rate for Dawson County Hospital District: The Board of Directors commenced the public hearing on the 2022 preliminary tax rate of 0.332644 per \$100 valuation for Dawson County Hospital District at 5:02 p.m.
  - **A.** David Sanderson, Board President, presented Colby Reeves, Chief Financial Officer, to present historical data prior to receiving public comment. Colby Reeves presented a power point presentation regarding the topics from the initial 2022 tax rate discussion, tax calculations for the 2022 tax year, tax rate comparison and net taxable value

comparison for 2021 versus 2022, and comparison of average household impact. Colby Reeves presented in response to the board's question, the 2022 preliminary tax rate of 0.332644 per \$100 valuation provides a tax rate increase without triggering an election or petition. The board had the opportunity to ask questions.

- C. The Board of Directors received public comments from the following citizen: Carter Schildknecht.

- **F.** After discussion, a motion was made by Steven Hatchett to adjourn the public hearing on the 2022 preliminary tax rate, , and seconded by Leslie Hawkins. Motion carried unanimously.
- G. David Sanderson, Board President, adjourned the public hearing on the 2022 preliminary tax rate at 5:26 p.m.

### 5. New Business:

A. Receive and Take Action to Adopt the 2022 Tax Rate for Debt Service for Dawson County Hospital District – David Sanderson, President of the Board.

David Sanderson presented to the board for board action to adopt the 2022 tax rates for maintenance and operation and interest and sinking in a separate motion to adopt the tax rate for the two combined as presented during the public hearing presentation. At the request of the board, Colby Reeves facilitated discussion with the Board of Directors and the public regarding the tax calculations for the 2022 tax year, 2021 tax rate comparison to 2022, and comparison of average household impact. After discussion, a motion was made by Steven Hatchett to approve the 2022 tax rate of 10.0174 cents per \$100 valuation for the interest and sinking portion of the debt service for Dawson County Hospital District, and seconded by Leslie Hawkins. Motion carried unanimously. The following board members were present and voted in favor of the 2022 tax rate of 10.0174 cents per \$100 valuation for debt service: David Sanderson, Board President; Steven Hatchett, Board Vice President; and Leslie Hawkins, Board Member. The following board members were absent from the meeting: Nicky Chapman, Board Secretary; and Mike Johnson, Board Member.

B. Receive and Take Action to Adopt the 2022 Tax Rate for Maintenance and Operations for Dawson County Hospital District — David Sanderson, President of the Board.

David Sanderson presented to the board for approval the 2022 tax rate for maintenance and operations for Dawson County Hospital District. After discussion, a motion was made by Steven Hatchett to move to approve the 2022 tax rate of 23.2470 cents per \$100 valuation for maintenance and operations for Dawson County Hospital District, and seconded by Leslie Hawkins. Motion carried unanimously. The following board members were present and voted in favor of the 2022 tax rate of 23.2470 cents per \$100 valuation for maintenance and operations: David Sanderson, Board President; Steven Hatchett, Board Vice President; and Leslie Hawkins, Board Member. The following board members were absent from the meeting: Nicky Chapman, Board Secretary; and Mike Johnson, Board Member.

- C. Receive and Take Action on Order to Adopt the 2022 Total Tax Rate for Dawson County Hospital District David Sanderson, President of the Board. David Sanderson read and presented to the board the resolution as provided in the board packet for adoption of the total tax rate for Dawson County Hospital District. After discussion, a motion was made by Steven Hatchett to accept this Order to adopt a tax rate at 33.2644 cents (0.332644) per \$100 valuation, as read and presented, and seconded by Leslie Hawkins. Motion carried unanimously. The following board members were present and voted in favor of the 2022 tax rate of 33.2644 cents per \$100 valuation: David Sanderson, Board President; Steven Hatchett, Board Vice President; and Leslie Hawkins, Board Member. The following board members were absent from the meeting: Nicky Chapman, Board Secretary; and Mike Johnson, Board Member.
