1. Receive and take action on the payments for the month of August 2023 Accounts Payable – Colby Reeves, Chief Financial Officer.

- **A. Freddy Olivarez, Chief Executive Officer** Freddy Olivarez, Chief Executive Officer presented to the board the following:
 - 1. Freddy Olivarez presented to the board the October Specialty Annex Calendar as provided in the administrative report packet;
 - 2. Freddy Olivarez presented to the board he attended the Toot 'N Totem grand opening. It is a great addition to the Lamesa community;
 - 3. Freddy Olivarez presented to the board Medical Arts had a good turnout of employee volunteers at the Lamesa Movieland Theater on Wednesday, August 30, 2023. The hospital is scheduled to volunteer next on Wednesday, November 29, 2023;

policy. Craig Carter, hospital legal counsel, has reviewed the policy and provided no recommended changes. A motion was made by Nicky Chapman to receive and approve the investment strategy policy, and seconded by Steven Hatchett. Motion carried unanimously. David Sanderson presented to the board for signature a resolution for approval of the Dawson County Hospital District's public funds investment policy and investment strategies as required annually.
