

Minutes of Regular Scheduled Board Meeting Dawson County Hospital District August 26, 2025

1. Call to Order: Steven Hatchett, Board Vice President, called the meeting to order at 8:31 a.m., with the above-mentioned members, staff, and guest present.

- **2. Invocation:** The invocation was given by Steven Hatchett, Board Vice President.
- **3. Pledge of Allegiance:** The pledge of allegiance was given by Steven Hatchett, Board Vice President.
- **4. Public Comment Session:** The Board of Directors entered Public Comment Session pursuant to the provisions of the Texas Open Meetings Act Government Code Section 551.001(4)(B) at 8:32 a.m.
 - **A.** The Board of Directors received no public comments.
 - **B.** Steven Hatchett, Board Vice President, adjourned the Public Comment Session at 8:32 a.m.

- 5. Public Hearing on 2025 Preliminary Tax Rate for Dawson County Hospital District. The Board of Directors commenced the public hearing on the 2025 preliminary tax rate of 0.298277 per \$100 valuation for Dawson County Hospital District at 8:32 a.m.
 - A. Steven Hatchett, Board Vice President, presented Colby Reeves, Chief Financial Officer, to present. Colby Reeves presented a power point presentation regarding the 2025 tax rates. The board had the opportunity to ask questions. Colby Reeves, Chief Financial Officer, facilitated discussion between Renae Thomas, President for Thomas & Thomas Financial Management Services, Freddy Olivarez, Chief Executive Officer, and the Board of Directors on tax rate calculations for non-new revenue and voter-approval tax rate; calculation of tax rates in relation to valuations, tax rate elections; recommended tax rate to be set at below the voter approval rate; projected tax collections in relation to valuations; hospital district services, expenses, and equipment needs.
 - B. Steven Hatchett, Board Vice President, presented an opportunity for public comment. The Board of Directors received no public comments.
 - C. Steven Hatchett, Board Vice President, adjourned the public hearing on the 2025 preliminary tax rate at 8:56 a.m.

6. New Business:

- A. Receive and Take Action to Adopt the 2025 Tax Rate for Debt Service for Dawson County Hospital District Steven Hatchett, Vice President of the Board. Steven Hatchett presented to the board for board action to adopt the 2025 tax rates for maintenance and operation and interest and sinking in a separate motion to adopt the tax rate for the two combined as presented during the public hearing presentation. After discussion, a motion was made by Nicky Chapman to accept the 2025 tax rate of 6.0840 cents per \$100 valuation that is for our debt service for Dawson County Hospital District, and seconded by Leslie Hawkins. Motion carried unanimously. The following board members were present and voted in favor of the 2025 tax rate of 6.0840 cents per \$100 valuation for debt service: Steven Hatchett, Board Vice President; Nicky Chapman, Board Secretary; and Leslie Hawkins, Board Member. - B. Receive and Take Action to Adopt the 2025 Tax Rate for Maintenance and Operations for Dawson County Hospital District Steven Hatchett, Vice President of the Board.

Steven Hatchett presented to the board for approval the 2025 tax rate for maintenance and operations for Dawson County Hospital District. A motion was made by Nicky Chapman to accept the tax rate of 23.6346 cents per \$100 valuation for maintenance and operations for 2025 for Dawson County Hospital District, and seconded by Leslie Hawkins. Motion carried unanimously. The following board members were present and voted in favor of the 2025 tax rate of 23.6346 cents per \$100 valuation for maintenance and operations: Steven Hatchett, Board Vice President; Nicky Chapman, Board Secretary; and Leslie Hawkins, Board Member. - C. Receive and Take Action on Order to Adopt the 2025 Total Tax Rate for Dawson County Hospital District Steven Hatchett, Vice President of the Board. Steven Hatchett presented to the board the resolution as provided in the board packet for adoption of the total tax rate for Dawson County Hospital District. After discussion, a motion was made by Nicky Chapman to accept the order to adopt a tax rate of 29.7186 cents per \$100 valuation for year 2025 for Dawson County Hospital District, and seconded by Leslie Hawkins. Motion carried unanimously. The following board members were present and voted in favor of the 2025 tax rate of 29.7186 cents per \$100 valuation: Steven Hatchett, Board Vice President; Nicky Chapman, Board Secretary; and Leslie Hawkins, Board Member. - D. Receive and Discuss for Possible Action Interlocal Agreement between Dawson County Hospital District and Dawson County, Texas Freddy Olivarez, Chief Executive Officer.

Freddy Olivarez presented to the board the renewal of the interlocal agreement between Dawson County Hospital District and Dawson County, Texas. A motion was made by Chapman to accept the interlocal agreement Nicky between County Dawson Hospital District and Dawson County. and seconded by Leslie Hawkins. Motion carried unanimously.
